

## AGREEMENT

I (we) acknowledge that the MDSA Guidelines for the Freestyle Event have been made available to me (us), that I (we) are familiar with their contents, and that I (we) agree to abide by these Guidelines at this MDSA Freestyle Event. I (we) waive any and all claims or causes of action I (we) might otherwise have against the GKCDTC, MDSA and any MDSA approved judge, judging of this event under MDSA Guidelines for the Freestyle Event. I (we) agree that the GKCDTC and MDSA have the right to refuse this entry for cause, which the GKCDTC or MDSA shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the freestyle event and of the opportunity to have the dog judged and to win prize money, ribbons or trophies, I (we) agree to hold the GKCDTC and MDSA, its members, directors, governors, officers, agents, superintendents or secretary and the owner or lessor of the premises and any employees of the aforementioned parties, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the competition premises or grounds or near the entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless for any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the GKCDTC or MDSA or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this event, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons. I am (we are) aware that BMI, ASCAP and/or other music licensing agencies may be entitled to a fee for the use of licensed music in any public performance, including but not limited to this freestyle competition. I (we) agree to be solely responsible for any fees due and owing for the use of their music in this competition and agree to hold MDSA, Inc., harmless and release MDSA, Inc., from liability for same.
